All funding programmes presented in this newsletter are open to researchers from all scientific disciplines.

1. FET Open: Future and Emerging Technologies - Challenging Current Thinking

The FET open funding scheme is interesting for innovative and high-risk research projects from all disciplines. Projects should have the following characteristics (FET "gatekeepers"):

- Radical vision (enabled by a new technology concept),
- Breakthrough technological target (as a first proof of concept),
- Ambitious interdisciplinary research (opening up new areas of investigation aiming at disruptive innovations).

Consortia must include at least 3 organisations from 3 EU member states / associated countries.

Funding: up to 3 Mio. Euros
Success rate (in 2018): 10,7%
Next cut-off-date: 13 May 2020

2. Science with and for Society

Science with and for Society (SwafS) is a work programme with a focus on the following thematic areas:

- Citizen science / science communication
- Skills development, including training in PhD programmes
- Responsible Research and Innovation (RRI)
- Gender equality plans, gender dimension in research.

The last calls of this programme in H2020 have a deadline on 15 April 2020.

3. ERC Consolidator Grants

- Grant for individual researchers of any nationality with 7-12 years of experience since completion of PhD (extensions possible)
- Research project can be conducted at the University of Würzburg or at another research institution located in the EU / Associated countries
- Evaluation criterion: **scientific excellence** of researcher (publications, awards, patents...) and research project ("ground-breaking")

Duration: Up to 5 years **Funding:** 2 mio. € (+ 1 mio €)

Deadline: 4 February 2020 (publication: 24 October 2019)

4. Brexit: What does it mean for EU projects?

The UK will leave the EU on 31 October 2019. What are the consequences for EU projects with UK partners?

- The UK government has committed to **guarantee funding** for all successful competitive UK bids to Horizon 2020 that are submitted before the UK leaves the EU, if there's a no-deal Brexit. The guarantee also covers all successful competitive UK bids to Horizon 2020 calls open to third-country participation submitted between Brexit and the end of 2020.
- Both the guarantee and extension commit funding to UK Horizon 2020 participants for the lifetime of projects.
- Third Country participants in Horizon 2020 are eligible to coordinate projects. Therefore, collaborative projects can still have coordinators from the UK.
- In case there is a no-deal-Brexit, projects which require a minimum of 3 partners from the EU /
 Associated Countries will not be eligible if the consortium consists of only 3 entities including an
 organisation from the UK.
- Also, with a no-deal-Brexit, mono-beneficiary projects within the ERC or the MSCA funding scheme will not be eligible.

Researchers are invited to register as experts and to become evaluators of EU proposals. This is a good opportunity to acquire background knowledge about evaluation procedures and might help you to write better proposals!
